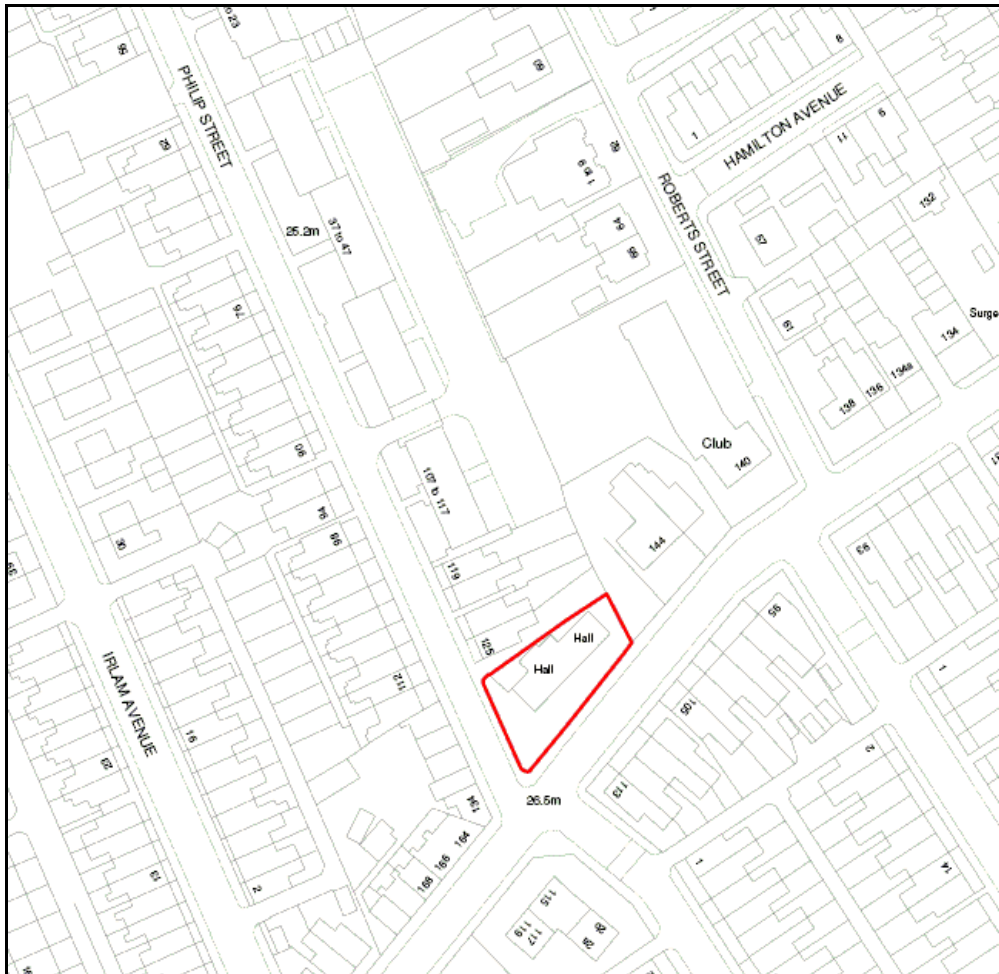

Property Details

An opportunity to acquire a prominent corner plot with potential for redevelopment in Eccles. Suited to a number of uses, subject to Planning Consent.

The site measures approximately 487.2sqm/0.12 acres. Please note that the highway fronting the site boundaries are at the back of pavements and not the knee rails on site.

Within in easy reach to Eccles Town Centre, which enjoys good local shopping facilities and is very well situated; served by junction 2 of the M602, which links Manchester City Centre to the M60, M6 and M62.

Eccles Railway Station is a regular stop on the Manchester to Liverpool line. Eccles is also a terminus of the Manchester Metrolink tram system, connecting with Manchester City Centre via Media City and Salford Quays.

The Trafford Shopping Centre is around 1.5 miles from the site.

The site may suit both residential and commercial uses including offices, retail or mixed use, subject to planning consent.
